1.	To confirm the minutes of the Meeting of the Anti-Ragging Committee held on 22/08/2024	The committee reviewed the minutes of the previous meeting. No objections or modifications were raised. The minutes were unanimously approved and confirmed.
2.	Discussion upon Anti-Ragging Policies and Guidelines	The committee deliberated on the existing anti-ragging policies and emphasized the need for strict implementation. Key discussions included: <ul style="list-style-type: none"><li>• Reaffirmation of zero tolerance towards ragging.</li><li>• Strengthening awareness campaigns among students through seminars, workshops, and orientation programs.</li><li>• Regular updates to anti-ragging policies in compliance with UGC regulations.</li></ul>
3.	Discussion on Campus's Monitoring and Surveillance Systems.	The committee discussed measures to enhance campus surveillance to prevent incidents of ragging. Key points included: <ul style="list-style-type: none"><li>• Regular patrolling by security personnel in campus premises.</li></ul>

4.	Discussions upon suggestion made by student representatives.	<p>Student representatives presented their suggestions, and the committee discussed their feasibility and implementation. Key suggestions included:</p> <ul style="list-style-type: none"><li>• Organizing interactive sessions between seniors and juniors to foster a positive environment.</li><li>• Creating a student mentorship program where senior students act as guides for new students.</li><li>• Implementing feedback mechanisms to assess the effectiveness of anti-ragging measures.</li></ul>

### ACTION TAKEN REPORT

Major action taken report of 35<sup>th</sup> Meeting of Anti-Ragging Committee held on 20/01/2025

Sr. No.	AGENDA	ACTION TAKEN
1.	To confirm the minutes of the Meeting of the Anti-Ragging Committee held on 22/08/2024	The minutes of the previous meeting were recorded and archived for future reference. Copies were circulated among the committee members to ensure transparency and continuity in decision-making.
2.	Discussion upon Anti-Ragging Policies and Guidelines	Awareness campaigns were scheduled, and updates to policies were initiated. Posters and online content were circulated among students. Special orientation sessions were organized for new students to educate them about their rights and the consequences of ragging. Faculty members were briefed to actively engage in anti-ragging initiatives, and a special committee was formed to monitor the implementation of these policies.
3.	Discussion on Campus's Monitoring and Surveillance Systems.	Security personnel were instructed to increase patrolling, particularly secluded areas in campus. An anonymous complaint submission system was introduced, allowing students to report concerns discreetly. The helpline was established, operational 24/7, and details were shared through posters, emails, and official notices.
4.	Discussions upon suggestion made by student representatives.	A student mentorship program was introduced, wherein senior students were paired with fresher's to guide them through academic and social aspects of campus life. Interactive sessions, including ice-breaking activities and discussions, were conducted to promote harmony among students. A structured feedback mechanism was developed, where students could submit their concerns or suggestions regarding anti-ragging measures anonymously or through regular student council meetings.
